WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Sri Vari College of Education, Thenarasambattu, Thiruvannamalai, Tamilnadu-606611 run by Kumaran Educational Trust, No. 29, Chellaneri Street, Thiruvannamalai District, Tamilandu vide order No. F.SRO/NCTE/B.Ed./2006-2007/8651 dated 24.10.2006 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2006-2007.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 16.02.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 30.04.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-16.
- **3. AND WHEREAS,** an order vide no. F.No.SRO/NCTE/APS05683/B.Ed./TN/2017-18/94845 dt. 12.09.2017 for the request of the institution for reduction of intake form 2 units to 1 unit in the B.Ed. course is permitted herewith subject to the conditions.
- **4. AND WHEREAS,** the matter regarding compliance by the institution of the condition of the revised recognition order, was placed before the SRC in its 388<sup>th</sup> Meeting held on 14<sup>th</sup> & 15<sup>th</sup> September, 2020 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 12.11.2021. The institution has submitted reply of Show Cause Notice on 26.11.2021.
- 5. AND WHEREAS, the SRC in its 405<sup>th</sup> Meeting held on 13<sup>th</sup> 14<sup>th</sup> December 2021 considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause notice was issued to the institution on 24.12.2021. The institution has submitted a reply to the Final Show Cause Notice on 10.05.2023 and 18.05.2023.
- 6. AND WHEREAS, the SRC in its 425<sup>th</sup> meeting held on 18<sup>th</sup> May 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sri Vari College of Education, Survey No. 42/1,2,3,4,5,6A, 7A, 56/5B & 57/3B, Chinnakangiyanur Village, Page 1 of 4

- 7. NOW THEREFORE, this order is issued permitting the institution i.e. Sri Vari College of Education, Survey No. 42/1,2,3,4,5,6A, 7A, 56/5B & 57/3B, Chinnakangiyanur Village, Thenarasambattu, Thiruvannamalai, Tamilnadu-606611 run by Kumaran Educational Trust, No. 29, Chellaneri Street, Thiruvannamalai District, Tamilandu for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions:-
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **8.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **9.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;

- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **11**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 12. The institution shall make available the list of students admitted on its official website.
- 13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
